SECTION 4 - FIRST AID MEASURES

Inhalation	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a doctor.
Ingestion	IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing.
