## SECTION 4 - FIRST AID MEASURES

<b>Inhalation</b>	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a doctor.
<b>Ingestion</b>	IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. Rinse mouth thoroughly with water. Have victim drink two glasses of water. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Call a doctor if you feel unwell.

## SECTION 5 - FIREFIGHTING MEASURES

<b>Specific hazards of the hazardous product (hazardous combustion products)</b>	Carbon oxides and other irritant/toxic gases and fumes.
<b>Suitable and unsuitable extinguishing media</b>	In case of fire: Use carbon dioxide, chemical powder agent and appropriate foam to extinguish surrounding products.
<b>Special protective equipment and precautions for fire-fighters</b>	During a fire, irritating/toxic smoke and fumes may be generated. Do not enter fire area without proper protection. <b>Precautions for safe handling</b>	Wear protective gloves/ protective clothing/ eye protection/ face protection. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing dust/fume/gas/mist/vapours/ spray. Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame. Storage area should be clearly identified, clear of obstruction and accessible only to trained personnel. Inspect periodically for damage or leaks.
